जयपुर के बजाज नगर इलाके में एजी कालोनी में रहने वाली आईआरएस अफसर बिन्नी शर्मा जयपुर में ही राजस्व विभाग की जीएसटी शाखा में पदस्थापित थी। उनके साथ दो बच्चे और उनकी मां भी रहती थी। जयपुर पुलिस के डीसीपी पूर्व गौरव यादव ने बताया कि देर रात बजाज नगर थाना पुलिस ने मौके पर पहुंच कर शव को जयपुरिया अस्पताल के मुर्दा घर में पहुंचा दिया था। शव का मंगलवार को पोस्टमार्टम करवाया गया।

पुलिस के अनुसार 35 साल की बिन्नी शर्मा के पति गुरप्रीत सिंह चंडीगढ़ में पदस्थापित हैं। यादव ने बताया कि पुलिस को मौके से अंग्रेजी में लिखा एक सुसाइड नोट भी मिला है। इसमें पारिवारिक कलह की बात सामने आ रही है।

बिन्नी ने इसमें अपने पति और सास पर परेशान करने के आरोप लगाए हैं। नोट में लिखा है कि दोनों ने उनके जीवन को बर्बाद कर दिया है।
